- (1) Taking into consideration of the eligibility criteria applicable for the post of Junior Liaison Officer viz., Educational Qualification/s (Prescribed & Essential), experience in the relevant field and publications in Research or Extension Journals / Articles in Magazines / Newspapers on the agriculture sector etc., as uploaded in the On-line Successful Submission of Applications and based on the report of the Departmental Scrutiny Committee (DSC) with regard to meet the eligibility criterion specified for the said post in terms of the Coffee Board (Cadre & Recruitment) Rules / Regulations in force, duly specifying number of posts reserved for different categories viz., Unreserved, Scheduled Castes (SCs), Other Backward Classes (OBCs), Economically Weaker Section (EWS) considering the principles of post-based rosters in the services of the Government of India, the short listed eligible candidates to be considered for verification of original testimonials/certificates/documents etc., **(at the ratio of 1:5)** list is prepared subject to verification of relevant Documents / Certificates and eligibility criteria. 
