The Central Public Information Officers (CPIO), Central Assistant Public Information Officers (CAPIOs) and First Appellate Authorities in Coffee Board were notified under Section 5(1) & 19(1) of the RTI Act, 2005 vide Notifications cited under reference (1) & (2). The respective First Appellate Authorities have to display Boards at their offices illustrating the jurisdictions of CPIOs for the benefits of the citizens for preferring Appeals against the decisions of the CPIOs. Similarly, CPIOs have to display Boards of their jurisdictional offices and addresses to facilitate filing of RTI applications.

Sub-section (1) of Section 5 of the RTI Act, 2005 stipulates that, the Central Public Information Officer shall provide information to persons requesting for the information under this Act and Sub-section (2) of Section 5 of the RTI Act 2005 stipulates that the Central Assistant Public Information Officers shall receive the applications for information and appeals under this Act for forwarding the same forthwith to the Central Public Information Officer and the Appellate Authority respectively.

On receipt of application, the respective Central Public Information Officers shall furnish the information to the applicants. Similarly, on receipt of Appeal, the respective Appellate Authority shall examine and dispose it off.

The Central Public Information Officers shall compile and prepare the monthly returns of the RTI applications received / disposed at their offices and forward the same to the Assistant Secretary, RTI & Grievances, Head Office by email viz., asrtigriceboard@gmail.com on or before 5th of the successive month without fail for compiling and forwarding the same to the Ministry.
