Sir,

I am directed to refer to Coffee Board's communication dated 23.2.2022 on the above-mentioned subject and to convey the approval for continuation of activities which are continued from Medium Term Expenditure Framework (MTEF) Period only subject to adherence of Modalities/guidelines followed while implementing the activities during the MTEF Period.


2. In terms of Department of Expenditure (DoE)'s OM No. 01(01)/PFC-I/2022 dated 01.02.2022 & 24.02.2022-

(i) fresh appraisal of the scheme, implemented by Coffee Board, shall be carried out for its continuation beyond 30.09.2022. During the period till 30.09.2022, the schemes may continue to operate, disburse funds and sanction new commitments even if such commitments may require expenditure beyond 30th September, 2022. However, the pace of expenditure including such commitment shall be reasonable for the time period and proportionate to the overall outlay recommended by the EFC (approximately 1/10th of the outlay envisaged over the 5 years).

(ii) Expenditure during the period upto 30.9.2022 will include budget of FY 2021-22 and half of BE of FY 2022-23 (up to 30.09.2022). DoE's restriction of half of BE 2022-23 must be adhered to.
