Sub: Implementation of ICDP during the remaining period of Fifteenth Finance Commission cycle up to 2025-26– Reg



The last date for receipt of DSS applications by the field offices was on 07.10.2024. As per the information provided by the Deputy Directors (Extension), all the offices have received applications more than the allocated financial targets.

In this regard, the CEO & Secretary has instructed to convey the following procedure to be followed while processing the DSS applications:

- 1) To sort all the applications zone wise chronologically.
- 2) To restrict the issue of TFR to the component wise allocated financial targets vide ref (3) to the list prepared in Sl.No.1 on first come first serve basis.
- 3) In case, any planter has applied for more than one activity, in such cases any one eligible activity as mentioned above, preferred by the grower shall be considered for issue of TFR, if number of applications received are more than the financial target.
- 4) To issue an endorsement to rest of the applicants / growers stating that “More number of applications have been received from the growers than the allocated financial target. Applications received based on the First Come First Serve basis have been considered for subsidy support to the tune of financial target and same is published on the Coffee Board’s website / office notice Board. Hence, your application for subsidy support is not considered”.
- 5) The list of growers who have been shortlisted for issue of Technical Feasibility Report (TFR), based on seniority, should be displayed on the notice board of the respective offices for the information of all. Further, office wise list may be sent to Head Office to place it on the Board’s website.
- 6) The DDEs shall periodically review the progress on TFR and complete issue of 100% TFR by 15th November in their respective region.

This is for strict compliance.
