

'Medium Term Framework period up to 31.03.2023 – reg.

This has reference to the circular under reference. The export incentive claims under the component '**Providing Transit/Freight Assistance for Coffee Exports**' for the export permits issued during the financial year 2022-23 are to be submitted as per the modalities for implementation of the scheme hosted in the Coffee Board's website URL <https://www.indiacoffee.org/15th-comission.html>

In this regard, all the registered coffee exporters are requested to submit their claims separately in the prescribed Performa for incentive towards export of High Value Green Coffee to far off destinations (FORM A) and Value-Added Coffees in retail pack as India Brand (Form B).

- i. It is to inform that the export incentive claims for the export permits **issued for the period from 01.04.2022 to 31.12.2022 to be submitted before 15.01.2023**. Since funds are available for processing and release of payments at present, it is requested to submit your claims on or before 15th January, 2023 so that the payments can be released quickly.
- ii. However, the applications received after 15.01.2023 will be processed upon availability of funds only.
- iii. The mere submission of export incentive claims may not be considered for payment unless the claims fulfil all the terms and conditions of the modalities/guidelines.
- iv. The eligible incentive claims will be processed on first cum first basis and release of the payments are subject to the availability of funds.

Sub: Extending Transit/Freight Assistance for Coffee Exports under the
'Medium Term Framework period up to 31.03.2023 – reg.

The Government has approved for continuation of the activities of the ongoing MTF period scheme 'Integrated Coffee Development Project' up to 31.03.2022. Accordingly, the export incentive claims under the component 'Providing Transit/Freight Assistance for Coffee exports' for the export permits issued from 1.4.2022 to 31.03.2023 are to be submitted as per the modalities for implementation of the component hosted in the Coffee Board's website URL <https://www.indiacoffee.org/15th-comission.html>

In this regard, all the registered Coffee Exporters are requested to submit their claims separately in the prescribed performa for incentive towards export of High Value Green Coffee to far off destinations (FORM A) and Value-Added Coffees in retail pack as India Brand (FORM B) as per the time lines listed under:

1. The export incentive claims for the export permits issued during financial year 2022-23 (i.e., permits issued from 01.04.2022 to 31.03.2023 only) has to be submitted within 30.06.2023 for consideration and release of payment.
2. The mere submission of export incentive claims may not be considered for payment unless the claims fulfil all the terms and conditions of the modalities/guidelines.
3. The eligible incentive claims will be processed on first cum first basis and release of the payments are subject to the availability of funds.

The time lines and conditions indicated above will be adhered strictly without any further relaxations.
