NOTIFICATION

Sub: Continuation of Implementation of "Integrated Coffee Development Project (ICDP)" Scheme during the remaining period of Fifteenth Finance Commission Cycle up to 2025-26 - Modalities / Guidelines for R&G - Reg.
Ref.: 1. Order No. EXTN/P&C/80(A)/2026-27/60 Dated: 20-05-2026

The Ministry of Commerce & Industry, Government of India has conveyed approval for General Guidelines for implementation of "Integrated Coffee Development Project (ICDP)" submitted by the Coffee Board for the remaining period of Fifteenth Finance Commission Cycle up to 2026-27.

Further, Board has approved the detailed Implementation modalities and the timelines of the Integrated Coffee Development Project scheme in circular dated 21.05.2026.

Hence, the approved Implementation modalities and guidelines of the "Integrated Coffee Development Project (ICDP)" has been hosted in the Coffee Board's website: www.coffeeboard.gov.in and the same is enclosed along with this notification.

The date of implementation of the scheme will be effective from the date of issue of this notification, dated: 25-05-2026. 'Applications for Technical Feasibility via India Coffee App for issue of technical feasibility reports will be entertained up to 14-08-2026 and Final claim application will be entertained up to 15-09-2026, subject to availability of funds.


Procedure of application:

- i) The application is invited **via "India Coffee App"** from eligible coffee entrepreneurs for issuing feasibility reports towards financial support for **establishment of New - Coffee Roasting and Grinding (R&G) Units**. The **"User manual for the applicants"** is enclosed as **Annexure 1**.
- ii) **Eligibility:** Individual units, Partnership firms, Pvt Ltd firms, Self-Help-Groups (SHG)/ Growers' collectives, Coffee Cafes interested to establish new coffee Roasting & Grinding units.
- iii) **Documents to be uploaded in support of the Feasibility Application:**
 - a) Notarized Copy of the lease agreement / rent agreement / ownership document in respect of the proposed site/ shop / building premises
 - b) Blue print / layout plan for the proposed R&G unit/facility.
 - c) Quotations issued by the supplier/machine manufacturers.

- iv) **The last date for receipt of Applications for Technical Feasibility is 14-08-2026.**
- v) No applications for Technical Feasibility will be considered after the end date.
- vi) The applications in support for **value addition R&G Unit** may be submitted *Via.*, **'India Coffee APP'**

- vii) The information provided by the applicant will be scrutinized and physical inspection/verification will be undertaken by Coffee Board officers for issuing Feasibility Report if/when required on a case to case basis.
- viii) The eligible applications will be processed on priority as follows:
- 1) Priority to applications from NE regions
 - 2) Women Entrepreneurs
 - 3) FPO's/SHG's
 - 4) Differently abled Individuals &
 - 5) SC/ST applicants
- ix) Applications shall be considered on first come first serve basis provided the applications are complete in all respects and subject to availability of funds.
- x) **Procurement, installation and commissioning of coffee machinery should be carried out by the applicants, only after the receipt of the Feasibility Report from the Coffee Board.**
- xi) On receipt of the Feasibility Report and the successful installation and commissioning of the newly established R & G unit machineries. The application for final claim may be submitted *via "India Coffee App"*. The claim will be processed after physical site inspection by the Divisional Head- Coffee Quality & officers of the Coffee Quality Division, Bengaluru. If the application is found liable for rejection, same will be communicated to the applicant *via India Coffee App*.
- xii) The **Scheme is NOT applicable** to R&G unit establishments who have **installed and commissioned machinery before the scheme notification dated 20-05-2026.**

Modalities for Implementation of:

Sub Component 2.4.1. Support for Value Addition: R&G Units

2.4.1: Support for Value Addition (R&G)

2.4.1.1: Objective: To enhance quality of coffee product and achieve value addition through roasting, grinding and packaging which will result in boosting domestic coffee consumption and entrepreneurship in the coffee sector.

2.4.1.2: Eligibility

Individual units, Partnership firms, Pvt Ltd firms, Self-Help-Groups (SHG)/ Growers' collectives, Coffee Cafes interested to establish new coffee roasting units.

2.4.1.3: Conditions

- i) The applicant's Unit should hold a valid license for the business from the respective statutory authorities.
- ii) Units who have availed subsidy in the XI and XII & MTF Plan period are NOT eligible for Subsidy.
- iii) Priority will be given to low/non-coffee consuming states.

2.4.1.4: Scale of subsidy

- i) Roasting Unit, **Gourmet** Roasting units **1Kg to <10Kg/batch** and Small Roasting units with a capacity of **less than 25 kg capacity** and Large Roasting units with a capacity of **25 kg or more** are eligible for subsidy support of **40%** of the machinery cost with a ceiling of Rs.15.00 lakhs.
- ii) For the SHG's, FPO's, women entrepreneurs, SC / ST and differently abled beneficiaries, subsidy support is at **50%** of the machinery cost with a ceiling of Rs.15.00 lakhs.

2.4.1.5: Components eligible for subsidy

New Units: The roasting, grinding and packaging machinery in any of the following combinations are eligible for subsidy

- a) Roasting machine, grinding machine and packaging machine.
- b) Roasting machine and packaging machine.
- c) Grinding machine and Packaging machine.

2.4.1.6: Priority

Applications shall be considered on first come first serve basis provided the applications are complete in all respects, subject to availability of funds.

2.4.1.7: Procedure of application

- i) The application for subsidy should be submitted to Coffee Board *Via., the 'India Coffee APP'*

before starting the works for obtaining a feasibility report. (Information provided by the applicant will be scrutinized and physical inspection / online verification for providing feasibility report will be done only if/ when required on a case to case basis). The applications will be processed and feasibility report will be provided on First in First out (FIFO) basis subject to availability of funds.

- ii) The information provided by the applicant will be scrutinized and physical inspection/verification will be undertaken by Coffee Board officers for providing feasibility report if/when required on a case to case basis.
- iii) Procurement, installation and commissioning of coffee machinery should be carried out by the applicants only on receipt of the Feasibility Report from the Coffee Board **via “India Coffee App”**
- iv) The application for final claim may be submitted via “India Coffee App” only on the receipt of the Feasibility Report and the successful installation and commissioning of the newly established R & G unit machineries. The claim will be processed after physical site inspection by the Divisional Head- Coffee Quality & officers of the Coffee Quality Division, Bengaluru. If the application is found liable for rejection, same will be communicated to the applicant **via India Coffee App**.
- v) Applications shall be considered on first come first serve basis provided the applications are complete in all respects and subject to availability of funds.

2.4.1.8. (1): Documents to be uploaded in support of the Feasibility Application

 - f) In case of SC /ST and differently abled category beneficiaries applying individually, caste / community / disability certificate (with disability of 40% and above) issued by the competent authority.
- i) Only on receipt of the feasibility report **via India Coffee App** from the Divisional Head (Coffee Quality), Coffee Board, the applicant should complete the purchase, installation/commissioning of the proposed coffee machinery. On successful installation and commissioning of R&G machineries. the Final Claims Applications should be submitted **Via ‘India Coffee App’** along with the documents mentioned in **para 2.4.1.9**.

- ii) The applications will be processed after the inspection by the officers of the Coffee Quality Division, Bengaluru on seniority basis and subject to availability of funds. If the application is found liable for rejection, same will be communicated to the applicant.

2.4.1.9: Documents to be uploaded in support of Final Claim application

- i) Copy of the blue print / layout plan for the proposed R&G unit/facility
- ii) Copy of the Photo identity like Aadhaar or Ration card or PAN card or Passport or Driving License or Election Photo Identity Card etc.

- vii) Copy of license from municipal authorities.
- viii) Copy of FSSAI license.
- ix) Copy of GST Registration Certificate.
- x) Copy of the Bank pass book of the applicant.
- xi) Photographs of the new machinery installed for which subsidy is claimed.
- xii) In case of SC /ST and differently abled category beneficiaries applying individually, caste / community / disability certificate (with disability of 40% and above) issued by the competent authority.

2.4.1.10: Disbursement of subsidy

- The subsidy shall be released to the applicant's bank account through PFMS in cases where the application is complete in all respects and found satisfactory and only after approval of post installation inspection report submitted by the Coffee Quality Division, Coffee Board, Bengaluru.
- The submission of application by the applicant or acceptance of the application by the office does not entitle the applicant for the eligible subsidy from the Coffee Board. The applicant is assured of release of eligible subsidy funds if technical feasibility report is issued and installation is found satisfactory as per the norms subject to the availability of funds.
- The Coffee Board reserves the right to amend, amplify or abrogate in its discretion any of the terms and conditions of the scheme without notice as it may consider necessary for efficient execution of the scheme and fulfilment of its objectives.
- Applications of persons who resort to making offers, rewards, gifts or any material benefit, or any coercion either directly or indirectly, to influence the sanction process shall summarily be rejected. Similarly, legal action will be initiated for recovery with applicable interest against applicants who obtain the subsidy benefit by wilfully furnishing wrong/incorrect information, misrepresentation and suppression of information.

4. Complete the registration process by entering the Name, Password, Confirm Password, Alternate mobile number, Email ID.



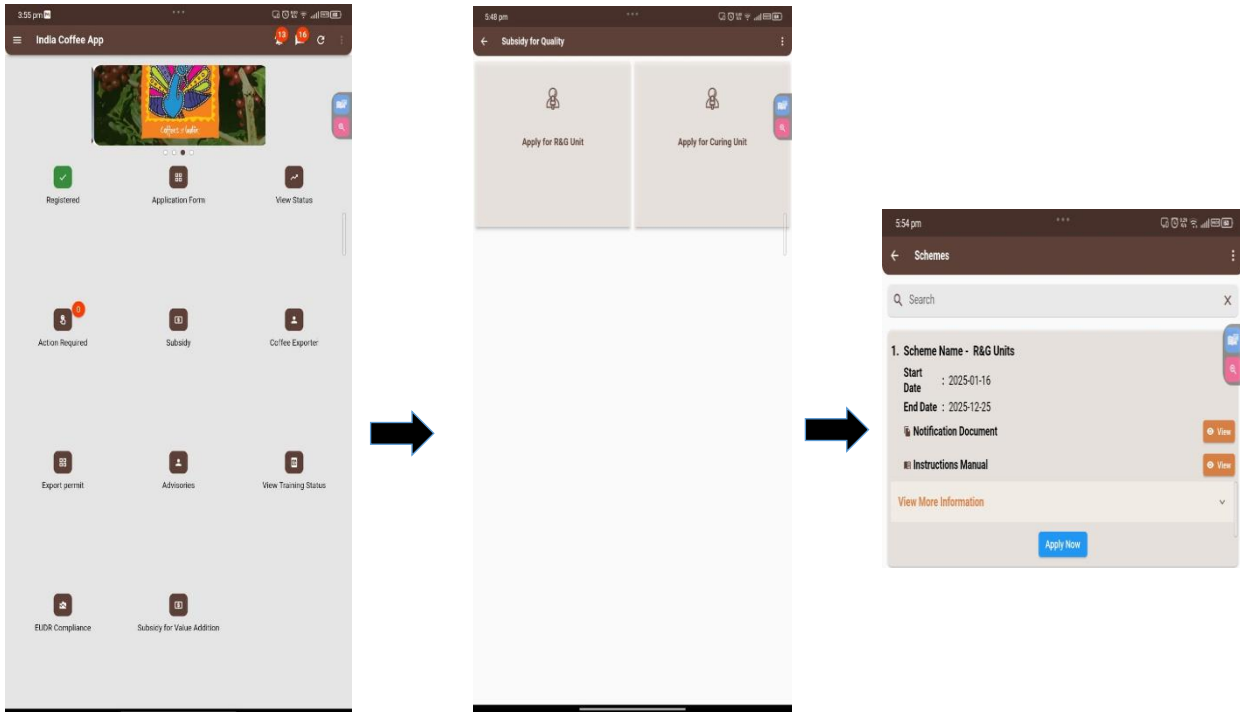

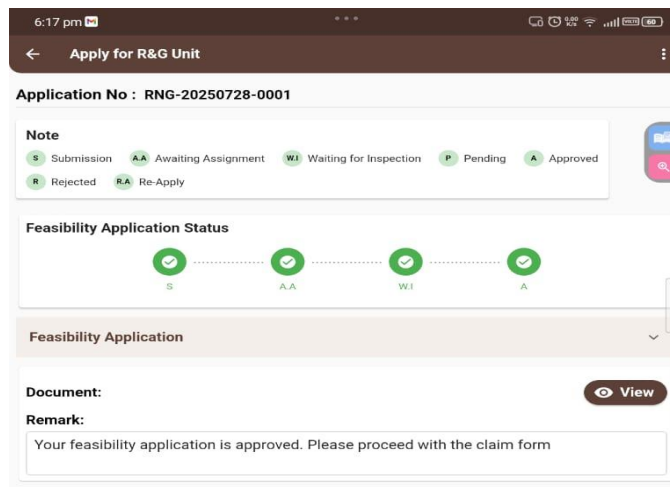

Log in to view Feasibility Report, Remarks, and Application Status. If positive, proceed to machinery procurement; if negative, correct issues and resubmit.



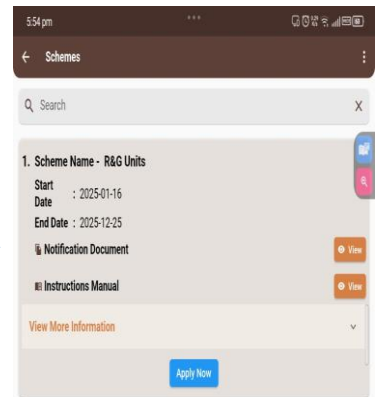
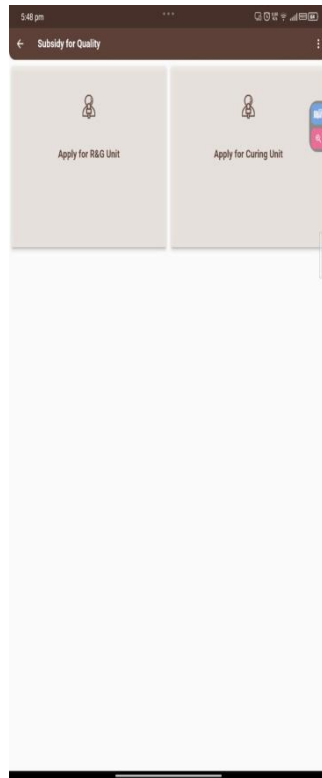
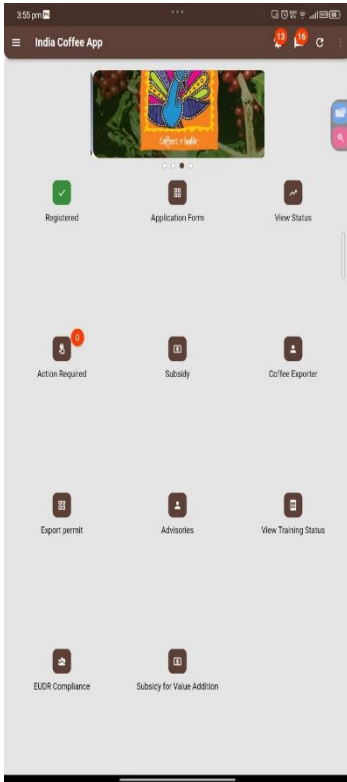

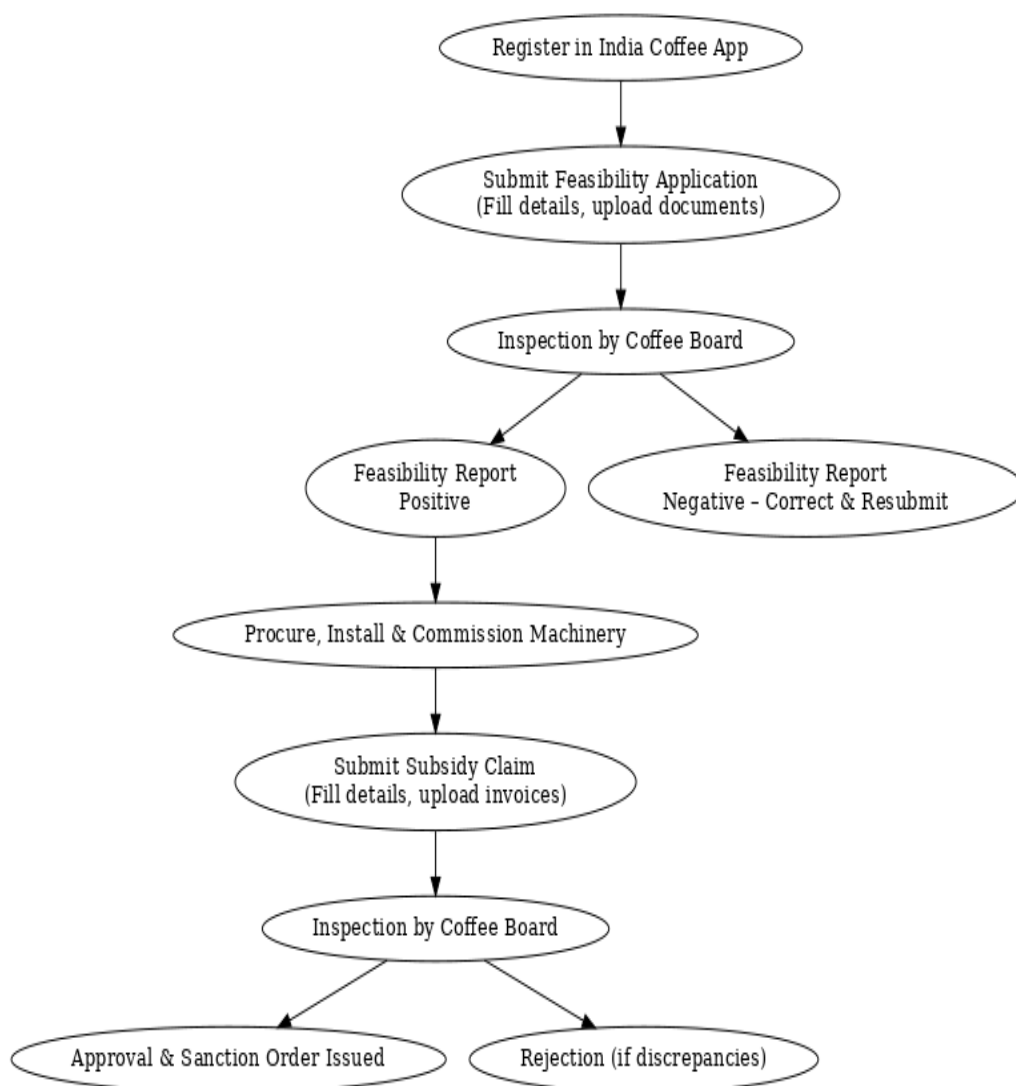
