



SUPPORT FOR COFFEE DEVELOPMENT PROGRAMME IN NORTH EASTERN REGION

SALIENT FEATURES

The Board is extending financial support for Expansion of Coffee, Consolidation, Quality Up-gradation, Raising of Coffee seedlings & Shade tree Saplings and Market Support activities during XI Plan period.

Eligibility Criteria:

- All individual growers who takes up new planting of coffee in suitable areas with recommended plant material are eligible for Expansion Subsidy.
- The growers who takes up consolidation/rejuvenation of the existing coffee holdings to improve productivity are eligible for Subsidy.
- Support for acquiring Baby Pulper and Construction of Drying Yard by the individual growers are eligible for subsidy under Quality Up-gradation.
- The beneficiary should possess and furnish the land records/possession certificate duly certified by the competent authority/village council.
- The activity once benefited during IX & X plan period will not be eligible for the assistance for the same activity to the same area/beneficiary under XI Plan period

Unit Cost & Scale of Subsidy:

2	Consolidation	---	Rs. 15,000/- per Ha. in 3 equal instalments @ Rs. 5,000/- each per Ha. during 1 st , 2 nd & 3 rd year of planting.

Support for Raising Coffee Seedlings & Mixed Shade Tree Saplings:

- Financial Assistance will be provided @ Rs. 3/- per Coffee seedling and Rs.5/- per shade sapling raised by the Group/ Community Nurseries to support expansion/consolidation of coffee area and encourage establishment of mixed shade in coffee plantations/holdings.

Market Support:

- Financial support for meeting the cost of collection, storing, curing, transportation and disposal of coffee produced in NE Region.

Release of Subsidy:

- The eligible subsidy for different activities completed by the growers will be released by the Board to the individual growers directly.

How to Apply

- ❖ The applications with required documents should be submitted to the concerned Liaison Officer.

**SUPPORT FOR COFFEE DEVELOPMENT PROGRAMME IN
NON TRADITIONAL AREAS (ANDHRA PRADESH & ORISSA)**

SALIENT FEATURES

The Board is extending financial support for Expansion of Coffee, Phasing out of Cauvery, Quality Up-gradation & Raising of Mixed Shade Tree Saplings activities during XI Plan period.

Eligibility Criteria:

- All individual growers who takes up new planting of coffee in suitable areas with recommended plant material are eligible for Expansion Subsidy.
- The growers who takes up replacement of old/susceptible Cauvery variety with recommended plant material are eligible for Subsidy under phasing out.
- Support for acquiring Baby Pulper and Construction of Drying Yard by the individual growers are eligible for subsidy under Quality Up-gradation.
- The beneficiary should possess and furnish the land records/possession certificate duly certified by the competent authority.
- The activity once benefited during IX & X plan period will not be eligible for the assistance for the same activity to the same area/beneficiary under XI Plan period

Unit Cost & Scale of Subsidy:

	Activity	Unit Cost (in Rs.)	Subsidy Amount (in Rs.)
1	Expansion	Rs. 60,000/- per Ha.	Rs. 15,000/- per Ha. in three equal installments of Rs. 5,000/- each during 1 st , 2 nd & 3 rd Year of planting
2	Phasing out of Cauvery	---	Rs. 10,000/- per Ha. in 2 instalments @ Rs. 6,000/- per Ha. during 1 st year & Rs. 4,000/- per Ha. during 3 rd year of planting.
3	Quality UP-gradation		
(i)	Drying Yard	Rs. 50/- per sq ft. & varies with size of the drying yard from 100 – 400 sq. ft.	Rs. 25/- per Sq. Ft which is equivalent to 50% of unit cost and depends on the size of the drying yard
(ii)	Baby Pulper	From Rs. 12,000/- to Rs. 15,000/- per unit.	50% of the unit cost

Support for Raising Mixed Shade Tree Saplings:

- Financial Assistance will be provided @ Rs. 2/- per shade tree sapling raised by the Group/ Community Nurseries to encourage development of mixed shade in coffee plantations/holdings.

Release of Subsidy:

- The eligible subsidy for different activities completed by the growers in Andhra Pradesh will be released by the Board through the Project Officer, ITDA, Paderu after physical verification/test inspection of the concerned activities conducted along with the ITDA, Officials.
- The eligible subsidy for different activities completed by the growers in Orissa will be released by the Board directly to the beneficiaries after conducting physical verification of the concerned activities.

How to Apply

- ❖ The applications with required documents should be submitted to the Project Officer, ITDA in case of Andhra Pradesh & to the SLO, Koraput in case of Orissa.
- ❖ The detailed guidelines and procedures to be followed are available with all the Field Officers of ITDA & Coffee Board.
